Re-Entry Residency Positions, Department of Anesthesia

The UBC Department of Anesthesia has <u>TWO</u> **PGY3** re-entry residency positions in Anesthesia, commencing July 1, 2024. These two re-entry anesthesia residency positions have a **3-year Return of Service (ROS) contract**. One position will complete their 3-year ROS within Vancouver Island Health Authority and the other will complete their 3-year ROS within Northern Health Authority. 2024 ROS contracts can be found here: Re-entry Program - Province of British Columbia (gov.bc.ca)

Eligibility

- Fully licensed practicing physician registered with a Canadian or a United States regulatory body
- Interested applicants will have completed at least two years of post-graduate training and be in active practice for a minimum of 12 months at the time of application
- Applicants must also be a Canadian citizen or permanent resident / landed immigrant
- Transfers from other residency programs will not be permitted
- Physicians currently fulfilling BC Return of Service commitments will not be eligible to apply for re-entry until full completion of their term

Application Process

A complete application package will consist of:

- 1. Official transcripts (for all post-secondary training such as a BA, BSc, Masters, PhD, etc and medical school transcripts)
- 2 Curriculum Vitae
- 3. If completed before discontinuation, proof of Medical Council of Canada Qualifying Examination (MCCQE) Part II
- 4. Personal statement discussing professional aspirations and suitability for practice in the Vancouver Island Health Authority. The maximum is one page.
- 5. Detailed description of residency training to date. This description should indicate which of the Royal College Anesthesiology specialty-training requirements (STR) have been successfully completed, including dates & duration. All potential non-anesthesia training deficiencies in terms of the STR should be listed. Refer to the Specialty-Training Requirements (STR) in Anesthesiology of the Royal College of Physicians and Surgeons of Canada (RCPSC), which can be found here: https://www.royalcollege.ca/content/dam/documents/ibd/anesthesiology-(anes)/anesthesiology-training-experiences-e.pdf
- 6. Three (3) letters of reference. Letters should include information similar to those items required by the Canadian Residency Matching Service (CaRMS) Reference guidelines CaRMS. One letter must be from the current Chief of Staff or Department Head. If the applicant is within 5 years of completion of residency, a letter from the program director or an individual knowledgeable about their residency training overall should also be provided. Provide names, email, addresses & contact information for all references. Please have the referees email their reference letter directly to Jay Park at anae.residency@ubc.ca
- 7. Two (2) additional references separate from item (6) above, including names, email, addresses & contact formation.

The position will be offered on a competitive basis by application. Shortlisted candidates will be interviewed. Interviews will take place in the first quarter of 2024.
